What's new?

- 1. The **health and safety** of all employees as we transition back to the buildings. This includes advocating about mask protocols as well as clarifying procedures
- In multiple conversations with CCPS, EACC advocated for clearer guidelines regarding implementation of the Families First Coronavirus Response Act (FFCRA). MSEA/NEA Action Items

1. Emergency Certificate regulations are adopted – MSEA continues to advocate for you

After much urging from MSEA and that of other stakeholders, MSDE and the State Board adopted an emergency certificate category for conditionally certified teachers and those in teacher prep programs. Basically, teachers in these two categories will have 6 months from the time the "state of emergency" is lifted in Maryland to complete the testing requirements needed to maintain their certificate or be able to seek a certificate as a new hire. This emergency certificate is no longer considered an emergency regulation and has been adopted by the State Board. Maryland remains under a state of emergency.
